Introduction of Speakers: Al Lund of Allied Charities – Our ability to Serve becomes more difficult each year. Speaking of his club the Osseo Lions, Al's speech mostly dealt with what his club experiences from charitable gambling. Of one month they paid the state \$20,624.00 in taxes, and had \$1,290 left for charitable work. They paid the state 78% of what remained after paying expenses and there expenses are below state average. They made less than the state, the manufacturer, the bar and the distributor. The charity is being taken out of charitable gambling. They pay 7 times what a for profit business pays in Minnesota in taxes. In May the Osseo Lions charity made one third of a cent per dollar wagered while the State made five cents per dollar wagered, or 16 times what they did. Much Discussion followed.
